Minutes:

Wildflowers: In churchyard grass has been cut around the wildflower areas.

Seeds will hopefully be planted at the Village Hall by Gardening Group before end of May. Seed patch planted by Family Blake in front of the wall surrounding their front garden. Update from Jane: Paul has first planted area in churchyard and then the area will be mown and he will then plant for a second time.

Townsends have been given a box of wildflowers for their grandson to plant on their land.

Sylvia shared card she received that can be planted to produce wildflowers (Mosney Mill)

ACTION POINT: Jane to action follow up planting of wildflowers by children in July and ask them to provide photos of plants for our noticeboard.

River bank picnic: Sunday 8th September.

ACTION POINTS: Need to ask Harriet to attend the next meeting to confirm how the picnic in her garden is to be run.

Sue R has spoken to WWT in connection about otters and they will see if anyone has any knowledge of otters in their database of members

Milly and others possibly create quiz: Spot the wildlife

Focus on Harriet's paddock for the picnic and follow up with Barbara's grounds at a later date.

<u>Village Hall Plan</u>: Aspirational plan has been approved and should be permanently displayed at the Hall. Fencing continues to be an issue around the playground. Extension of car park to happen. Hedgerow won't be disturbed until after September.

Cotswold National Landscape attended the site 27th March to walk around and offer some guidance but have failed to put anything in writing.

Caring for Cotswolds suggested as a possible for funding but no funding to be released until end of year.

Heart of England Forestry: attended site and very helpful and awaiting report of funding and tree density available.

Might be worth applying to the National Lottery Community fund once we have an idea of cost and what trees might be suitable.

ACTION POINT: Peter still chasing Cotswold National Landscapes for a report of what trees and where to plant and the density and any subsidies available.

<u>Bird Watch</u>: Update from Nick: Blue Tits fledged over the weekend and swifts have returned but not nesting at Nick's. Kestrel has been spotted at the Church tower. Leamington peregrines falcons are now hatched and names being sought for them on line at Leamington Town Hall.

Swift talk at The Kiln Shed, Whichford Pottery Saturday 15th June 7.30pm

<u>Water Testing of the River Stour</u>: Weekly testing occurring and volunteers from the group are testing in pairs: Amanda, Nick, Ian, Sue R, Sue L, Barbara, Trevor and Annie, Chris and Kerri.

ACTION POINT: Milly will continue to contact volunteers weekly to schedule testing and testers to provide Milly with data for her to upload to River Avon database. Issue with cows and calves now in Phillip's field. May need to consider testing at another site if cows become an issue.

Luke McCusker, a Senior River Ranger from Severn Trent Water has offered to organise testing the water on the following date: <u>Sunday 23rd June 10-1pm Milly will update those</u> interested nearer the time.

Blackdown Farm: ACTION POINT: Sue to contact the lady at Blackdown Farm which has been re-wilded to establish if we can visit independently as a group.

Professor of Ecology at Oxford Uni Owen Lewis (owen.lewis@bilogy.ox.ac.uk) agreed that he would be happy to leave moth traps in gardens overnight and then the following morning return and talk with the group about what has been trapped.

He suggested 7 - 8 June THIS DATE IS NOW CONFIRMED.

He will come Friday night at 8.30 with 4 traps. One needs mains electricity. Need to be near trees and in people's gardens. Ally, Sue W, John and Annie L happy to host. Meet Fri evening at village hall.

Traps will be opened by him at the Village Hall on Saturday June 8th, which is also a village coffee morning. Sue R has already told Christine this will be happening and we will support the coffee morning and Kerri will speak to Christine to check what help she needs.

ACTION POINT: Milly has designed poster to advertise for June moth reveal. Sue W 6, Sue R 10, John 1, Jane 8 flyers to deliver to families in the village. 2 posters on noticeboards Ally B. Plus invite WASPS for Saturday reveal Sue W
