

## Parish and Partners Foreword

Dear All,

**Welcome to a packed edition of the Parish and Partners newsletter, this continues to be an exceptional busy time for the Council, again thank you for your ongoing support.**

Firstly, I wanted to remind you of the next meeting of the Parish Forum, this session will be held online at **6pm on Thursday 26 June**. As you will be aware we undertook a consultation exercise on the issues that you would like discussed at these meetings. For our next meeting, the following issues will be covered:

- An update Local Government Reorganisation, including the informal consultation on Community Governance Reviews
- An overview of the Council's Enforcement function
- A discussion in relation to flooding with Andrew Richardson - Flood Risk Advisor from the Environment Agency

In relation to the Informal Consultation - Community Governance Review, hopefully you will all be aware of the email sent by the Council on 1 June which is seeking views on whether your areas would benefit from a review of structures. There is still plenty of chance to respond as the consultation runs until 11 July. As mentioned in the message if you have any queries or questions and you would like some assistance, then please do not hesitate to contact Macer Nash by either phone, email or through MSTEams.

Obviously, the prospect of Local Government Reorganisation for Warwickshire remains a significant issue for the Council. As discussed last time the Council following an invitation from central government is required to make a formal submission for our area by 28 November 2025. When the Council makes this submission, it must address the six criteria which the Government will assess all submissions, these being:

1. A proposal should seek to achieve for the whole of the area concerned the establishment of a single tier of local government.
2. Unitary local government must be the right size to achieve efficiencies, improve capacity and withstand financial shocks.
3. Unitary structures must prioritise the delivery of high quality and sustainable public services to citizens
4. Proposals should show how councils in the area have sought to work together in coming to a view that meets local needs and is informed by local views.
5. New unitary structures must support devolution arrangements.
6. New unitary structures should enable stronger community engagement and deliver genuine opportunity for neighbourhood empowerment.

Since our last edition, the Council has received feedback from central Government on the 'interim plan' which was submitted in mid-March. As previously discussed the 'interim plan' included two options for Local Government Reorganisation, a single unitary Warwickshire option, and a two unitary (North and South) option for Warwickshire. This feedback will be published soon and will be helpful in finalising our submission.

As mentioned above, the Council is still developing its final proposals for Local Government Reorganisation. To help inform this position the Council will be undertaking extensive engagement with the public and all other stakeholders including Town and Parish Councils. Before the engagement process commences however, it is appropriate that the Council expresses its 'preference' for Local Government Reorganisation to be used as the basis for the consultation. This will mean that the Cabinet and Full Council at the meetings being held on 7 and 14 July respectively, will be considering the Council's position. Papers for this meeting are scheduled to be published on 27 June 2025.

Cllr Susan Juned, Leader of Stratford-on-Avon District Council says: *"It's been two years since our administration was first installed, and we continue to make strides in delivering on our Council Plan. We remain committed to supporting local residents, collaborating with communities, and addressing both everyday challenges and larger issues. While there are still many challenges ahead, it's crucial that we listen to and respond to the priorities of our residents across the District."*

*"Over the past year, we've expanded recycling initiatives, including the introduction of coffee pod and soft plastics recycling, which has helped us achieve the third-highest recycling rate in England at 61%. We've also developed a project plan for new community facilities in Upper Lighthorne and introduced a dedicated Rural Crime Officer. Additionally, we've adopted a number of masterplans, and the South Warwickshire Local Plan, which we are developing in partnership with Warwick District Council, continues to progress."*

*"Balancing the books in local government remains a significant challenge, but we are proud of our financially sound position. This achievement is especially notable given rising costs, increased demand for services, and shrinking central funding. Our budget this year reflects the need to tackle pressing issues such as the cost of living, affordable housing, community grants, improved leisure facilities, economic development, and climate change action."*

*"The uncertainty surrounding local government re-organisation poses a challenge, but we are committed to ensuring that residents continue to receive high-quality services in the coming years. Resilience to financial cuts and challenges is key. Our ambition is for this District Council to be recognised as a leader in supporting residents, local businesses, protecting the environment, addressing climate change, and driving sustainable innovation in services for the future."*

## Recycle more as recycling service expands!

Since April, residents in the District have been able to recycle more from their doorsteps.

Stratford-on-Avon District Council has introduced an additional recycling service for the collection of plastic bags and wrapping, collected fortnightly within the normal fully commingled recycling service.

Recycled plastic bags and wrapping can be used to make new plastic products such as plastic packaging, 'bags for life', boxes, bins, and agricultural and construction materials.

### Recycling plastic bags and wrapping is easy!

Just make sure that:

1. Your plastic bags and wrapping should be empty and free from food residue and other contaminations.
2. Place your plastic bags and wrapping into your recycling bin, loose, with your other recyclables.
3. Place your recycling bin at the kerbside on your collection day.

Items should not be put within one another or fill bags with recycling.

### Did you know?

**Stratford-on-Avon District Council has the third highest household recycling rate in England.**

Figures published by Defra, show Stratford-on-Avon District Council had the third highest household recycling rate in England last year (2023/24), with a 61.0%; a jump of two places in the league table after seeing a 1% increase from the previous year.

Julie Lewis, Head of Environmental and Neighbourhood Services, said: *"This is a huge success and it's a testament to our residents and their commitment to recycling. It is an amazing achievement, and we would like to thank our residents and our continued successful partnership with waste collection contractor, Biffa Waste Services Ltd, alongside the hard work of our council officers for this milestone."*

*"We aim to make our collection service easy to use with the continued challenge to keep reducing and reusing and increasing the materials that can be recycled directly from your front door."*





## Stratford-on-Avon District Council to host health screening events across the District

**Stratford-on-Avon District Council has joined together with the Graham Fulford Charitable Trust (GFCT) to offer a series of health screening events for both men and women across the District.**

The events will enable men and women to have a number of health tests from a simple blood test, allowing them to, where necessary, seek further advice or action via their GP.

The tests on offer cost £14 each, subsidised by the District Council and are:

- For men over 40 - PSA (Prostate Screening)
- For men and women aged 18 and over - diabetes and cholesterol

**Booking is essential and places are filling up quickly.**

The events are taking place on:

- Saturday 12 July at Southam Leisure Centre, Welsh Road West, Southam, CV47 0JW
- Saturday 2 August at The Greig Leisure Centre, Kinwarton Road, Alcester, B49 6AD
- Saturday 13 September at Stratford Leisure Centre, Bridgeway, Stratford, CV37 6YX
- Saturday 11 October at Shipston Scout Hut, New Street, Shipston-on-Stour, CV36 4EW

If the event is fully booked in your local area, please look at booking another event in the District.

The events will run from 10am until 2pm at each of the locations and people are able to book at a discounted rate of £14 for each test.

The first event took place on Saturday 31 May at Stratford Leisure Centre, where 158 were tested. The second event took place on Saturday 14 June at Studley Leisure Centre where 70 were tested.

Cllr Liz Coles, Housing and Customer Services Portfolio said: *"Increasing awareness of prostate cancer and other health conditions through screening is crucial to helping people across Stratford-on-Avon District remain vigilant about their health. Early detection significantly improves access to timely support and treatment."*

*"I strongly encourage all those who are eligible to take advantage of these screening events. This initiative is part of our ongoing commitment to supporting residents in living full, healthy lives and achieving their potential, in line with the priorities in our Council Plan"*

#### Investing developer monies into the District

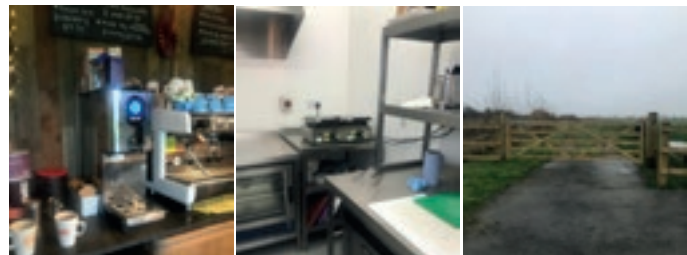
The Community Infrastructure Levy (CIL) is a charge levied by the District Council on new development in the area. CIL monies can be used to help fund the infrastructure needed to support development.

## Stratford Community Diagnostic Centre: Building progress and timeline

**Stratford's Community Diagnostic Centre (CDC) is part of a national programme to transform diagnostic services by offering a wide range of elective tests outside of hospital settings.**

It is a key development to deliver faster and more accessible diagnostic services for patients. Funding for the project has been through £6m national funding and a £1m Community Infrastructure Levy grant from Stratford District Council.

Councillor Susan Juned, Leader of Stratford-on-Avon District Council, said: *"Having a locally available Diagnostic Centre will be helpful in providing early diagnosis and healthy outcomes for our residents. We need to provide proper health infrastructure as part of the development, so I am glad that the funding was able to relieve pressure on the NHS and provide a useful needed service."*

Diagnostic services will be available from June 2025, following a phased timeline:

- Monday 9 June – Mammography
- Monday 16 June – Ultrasound
- Monday 23 June – Respiratory
- Monday 23 June – Cardiology
- Monday 14 July – CT



Suki Rai, Interim Associate Chief Operating Officer, said: *"Stratford's new Community Diagnostic Centre is already transforming patient care by bringing key diagnostic services closer to home. Offering MRI, CT, ultrasound, X-ray, and mammography under one roof, the centre is helping to reduce hospital pressures and cut waiting times. It gives our patients quicker access in a calmer, more convenient setting. This new model not only supports earlier diagnosis and treatment, but reflects a real shift towards delivering healthcare where it's most needed, easing the pressure at our acute hospital sites."*

## Introducing the Hollie Guard app - a free personal safety app

Stratford District Council's Community Safety team are promoting the use of this free, personal safety app designed to protect victims from violence and incidents, record evidence and alert emergency services.

The app was developed by the charity the Hollie Gazzard Trust, which was set up after the murder of Hollie Gazzard at her salon in Gloucester in 2014 by her then boyfriend – Asher Maslin, who had actively stalked Hollie during an abusive relationship.


### How it can help

Hollie Guard turns your smartphone into an advanced personal safety device at the touch of a button. If in danger simply shake your phone to generate an alert, your location, audio and video evidence of the incident will automatically be sent to your emergency contact via text and email. Shake it again and it sends out a high pitched alarm and the flash starts to strobe, in order to attract maximum attention.

From the moment Hollie Guard is activated, your location is tracked and can be viewed in real time by your emergency contact. Evidence is not stored on the smartphone but on secure servers so that it can be used as future as evidence.

### The Hollie Guard app:

- acts as a personal alarm
- allows you to send an alert to your emergency contacts
- share your location and start to record video and audio evidence.

## Meals on wheels in Warwickshire

WRCC, a local charity that supports rural parishes across Warwickshire, runs the Community Food Fleet as a not-for-profit 'Meals on Wheels' service covering the whole of Warwickshire. Similar services have been closing in recent years and are now supported by fewer than one in five councils in England due to cost cutting.

Our 'Meals on a Mission' approach means we provide our delivery service 365 days a year across the whole of Warwickshire – so you or family members need never be without a hot meal, whether every day or just needed occasionally. For many people the service is about 'more than meals.' It can help keep you (or your relatives) living independently while providing reassurance that someone is checking in on a regular basis. Several of our drivers used to work for the 'Meals on Wheels' service so are a familiar face and they're used to helping people complete meal choice forms, plate food, or get your cutlery to help make mealtimes easier.

Our friendly drivers are enhanced DBS checked and trained to carry out basic well-being and safety checks when they deliver meals, giving you peace of mind. Many of our customers have limited mobility and our drivers are used to using key-safe access to customer homes. There's a wide choice of tasty and nutritious meals to choose from, with soups, main meals and desserts on offer seven days a week, 365 days a year. We also include low fat, low salt, gluten free, vegetarian and vegan options, as well as texture modified meals if softer foods are required.

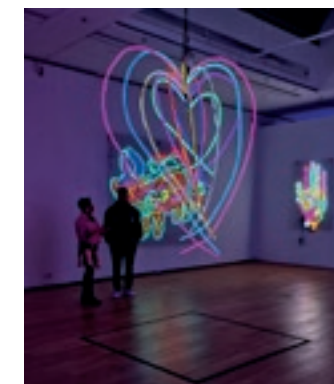

We ALL have a DUTY OF CARE, to ensure our household or business waste is disposed of legally and not fly tipped. Avoid an UNLIMITED FINE or PRISON SENTENCE by following the S.C.R.A.P. code:

- S**uspect ALL waste carriers
- C**heck with the Environment Agency on 03708 506 506 that the person(s) taking your waste away is licensed
- R**efuse unexpected offers to have your waste taken away
- A**sk what will happen to your waste when removed
- P**aperwork should be obtained – get a full receipt



Did you know?

Under section 34(2A) of the Environmental Protection Act 1990, Household Waste Duty of Care, you can be issued a Fixed Penalty Notice of up to £1,000 if you do not dispose of your waste correctly.

This includes:

- If fly tipped waste is traced back to **YOU**
- If **YOU** failed to make appropriate checks to ensure that the transfer of **YOUR** waste was to an authorised person(s)
- If **YOU** forget to check if the waste carrier is registered to remove **YOUR** waste
- If **YOU** forget to get a Waste Transfer Note or receipt for the waste which gives a description of the waste, where it was collected from and where it is being disposed

If **YOU** fail on any of the above, then **YOU** may receive a Fixed Penalty Notice or face prosecution.

## Overview and Scrutiny Committee Meeting updates

The Overview and Scrutiny Committee (OSC) has held three meetings since the last update in March.

### 7 March

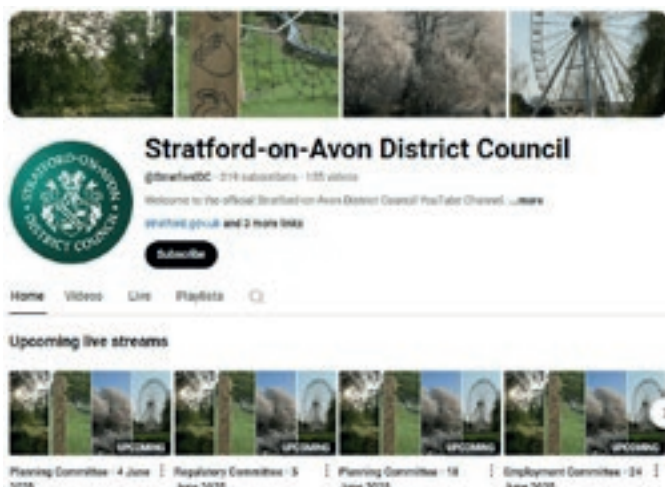
Officers from Warwickshire County Council attended and gave an update regarding digital connectivity across the District, including the rollout of rural broadband and improving 5G connectivity.

At the same meeting, the Committee agreed its Annual Work Programme, after inviting all councillors and parish councils to contribute suggestions. Members of the public have since also been consulted, and suggestions from residents will influence the future work programming.

The Outline Business Cases for the Canal Quarter District Heat Network and the Honeybourne to Stratford-upon-Avon Railway Line, Quarter 3 Performance Monitoring, and a report from Sherbourne Recycling Limited were also considered.

### 14 March

At an extraordinary meeting, the OSC considered the Council's Interim Plan for local government reorganisation proposals. The Chief Executive gave members a detailed presentation, and members scrutinised each aspect of the Plan carefully. It was decided that the Committee would receive a brief update on work towards the submission of a final proposal to the Government (which would be by 28 November 2025), and that an in-depth session regarding the implications of reorganisation on the District would be held in the summer. The Council approved the Interim Plan on 17 March 2025.



### 4 April

The meeting saw a return to regularly scheduled programming, with consideration of the results of a survey on public participation and the following Cabinet items:

- Round Three of the Community Climate Change and Nature Recovery Fund;
- Community Infrastructure Levy – Update to Infrastructure List;
- Single Equality Scheme Targets - 2025/26;
- Performance Management Framework 2025/26: Proposed Key Performance Indicators and Council Plan Actions for Year Two; and
- Allocation of UK Shared Prosperity Funding (UKSPF) 2025/26 for Communities and Place Projects.
